



About Conference

The conference is held under the patronage of the dean of the Faculty of Business Economics of the University of Economics in Bratislava with seat in Košice, doc. RNDr. Zuzana Hajduová, PhD., mim. prof.

The aim of the conference is to give a comprehensive overview of the scientific-technological research relating to rules and incentives, or management practices that contribute to the overall sustainability and confront the current situation of European economic practice, progressive technical and system innovations in industry, business economics and production management in response to international, European strategic development documents (especially Europe 2020 Strategy, Horizon 2020, Sustainable Production and Green Growth) and implementation of the best available techniques and technologies (BATT), which clearly induces the development trends of research and development, modernization of scientific infrastructure and improvement of overall conditions for research and development in technical sciences and production management.

Information for Authors

Conference Proceeding of Abstracts of Research Papers will be made up of abstracts listed in the Application Form as an output of the conference on the date of its beginning on **18. 05. 2017**. Conference Proceeding of Abstracts of Research Papers will receive the main (first) author.

Conference Proceeding of Research Papers from the conference will pass the review and will be published in the scientific publication "**New Trends in Process Control and Production Management**", which will be published by CRC Press / Balkema, Taylor & Francis Group, Netherlands (www.crcpress.com, www.taylorandfrancis.com) and will be submitted for indexing in the **Scopus** database. Conference Proceeding of Research Papers will receive the main (first) author.

One paper can have maximum four authors; each author may be a co-author of maximum three papers and maximum once referred as the main (first) author.

Required range of the paper: 6 pages. Every other page of the paper will be charged amount of **15 €** per page.

It is appropriate if the paper contains at least 5 citations of papers located in the **Scopus** database.

Language of the paper: English

The paper presentation: available PC, PowerPoint and Projector

Conference languages: Slovak, Czech, Polish and English
